### ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

#### Errorhead, Inc.

Pursuant to the provisions of Chapter 607 of the Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article IV is amended to read as follows:

#### "ARTICLE IV

This corporation is authorized to issue 4,682 common shares of One Dollar (\$1.00) par value common stock. Except as otherwise provided by law, or any agreement between the shareholders, the entire voting power for the election of directors and for all other purposes, shall be vested exclusively in the holders of the outstanding common shares."

- 2. In all other respects not inconsistent with the above, the Articles of Incorporation filed on the 28<sup>th</sup> day of November, 1984 in the office of the Florida Secretary of State and as amended by the Articles of Amendment to Articles of Incorporation filed on the 12<sup>th</sup> day of February, 2004 in the office of the Florida Secretary of State are hereby ratified, confirmed, re-executed and republished in their entirety.
- 3. The shareholders of Errorhead, Inc., unanimously adopted these Articles of Amendment to Articles of Incorporation of Errorhead, Inc. by consent on the 774day of MARCH, 2010, in the manner prescribed by the Florida General Corporation Act.
