and to insert in its place the language:

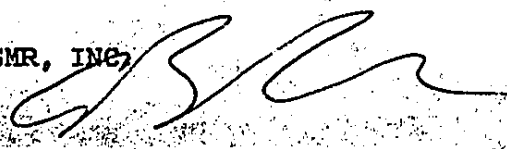
"70,000 shares of common stock of par value of
