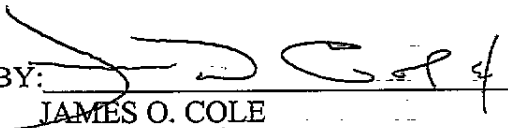
THE NAME OF THE CORPORATION IS SPITFIRE PROPERTIES, INC.
