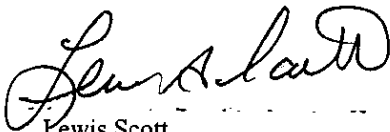

My current address is 6890 - 142nd avenue. So, the annual corporate report first report, the second late notice must have been mailed to that address of record and NEVER forwarded to me new address. We never received any of the proper filing forms. Please correct your records and process this annual report as soon as possible.
