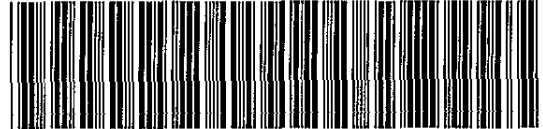

3. Article I of the Articles of Incorporation is hereby amended to read as follows:


ARTICLE I - NAME OF CORPORATION
