Minutes for January 11, 2006 Meeting

The meeting was called to order approx. 7:10PM at the Clubhouse by Ed Murphy, President.

.Ed announced that Ed Redivo, Vice-Pres. and Peggy Schaefer, Treas. had resigned because they bought a share in Country Park. There were 13 members present. Ed Murphy read the Treasurer's report; Mary Powers, Sec'y, read the minutes of the last meeting (March 22, 2005).

Mary Schwarz move that the minutes be accepted as read; Emil Barthel seconded the motion. Carolyn Buell moved that the dues be kept at \$5; seconded by Mary Powers; all yea. There was some discussion on the price of the share and how it evolved.

Ed invited Jack Morris to attend the meeting and when he came we went over some concerns the Homeowners had expressed at our last meeting.

- 1. If changes in the rules are discussed at the Shareholders meeting, we would like to know about them before they are voted on: Jack said if changes are made and voted in, they won't be put into effect for 90 days, giving us a chance to object if we want to.
- 2. If selling a unit, can we tell the prospective buyer that he can or cannot buy a share: Jack said that since Dec. 2005, we can tell them that they can buy a share.
- 3. Do we need fire hydrants throughout the park? Jack said the hydrants around the outside of the park are sufficient.
- 4. Need to know the responsibilities of the Coop and those of the Homeowners. The land belongs to the Coop. They are responsible for any accident on the land. An accident on the driveway would be covered by the liability clause of the property insurance.
- 5. What's the protocal for problems- do we talk to the Board or to the management? Jack said to call the Management. Closest contact is in Pasco Co.

The following questions were brought up at this meeting:

1. Do we have sufficient electric power for the park? Some loss of power, particularly in the summertime. Jack said he would look into the power losses.

2. Are we going to have a maintenance man this year. Jack said they decided to try it without one. Residents volunteer and if necessary, the Coop would hire the work done.

New business: Carolyn Buell said she would be on the Activities Committee. Mary Powers said she'd be Sec'y-Treas..Skip Frucelle A said he would be Vice-Pres.

The President made a motion to adjourn, Skip seconded it .
