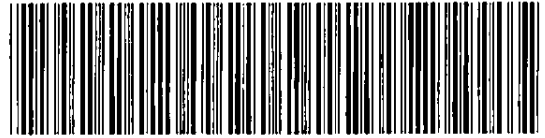

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION
OF
ASSEMBLY FASTENERS, INC.

The undersigned President of ASSEMBLY FASTENERS, INC., a Florida corporation (the "Company"), desiring to amend the Articles of Incorporation of the Company pursuant to the terms of Sections 607.1003 and 607.1006, Florida Statutes, is submitting to the Department for filing these Articles of Amendment to the Articles of Incorporation, and states as follows:

1. The current name of the Company is ASSEMBLY FASTENERS, INC.
2. The Company was formed as a corporation under the laws of the State of Florida by the filing of Articles of Incorporation (the "Articles") with the Florida Department of State (the "State") on December 18, 1984 under the name "Tropic Fasteners Inc." and assigned Florida document number H34802.
3. The Articles of the Company were amended on or about November 16, 2005 by the filing of Articles of Amendment changing the Company's name to Assembly Fasteners, Inc.
4. The Articles of the Company are hereby further amended to change the name of the Company to "HJW Ventures, Inc."
4. These Articles of Amendment (the "Amendment") to the Articles of the Company were approved by all of the shareholders and all of the directors of the Company on November 12, 2024.
