WHEREAS, the Articles of Incorporation of **WINN AND JORGENSEN, P.A.** (formerly George C. Winn, P.A. ) were filed with and approved by the Secretary of State of the State of Florida on the 26th day of December, 1984, effective the 1st day January, 1985; and

WHEREAS, Amendments to the Articles of Incorporation of **WINN AND JORGENSEN, P.A.** were filed with and approved by the Secretary of State of the State of Florida on July 14, 1988, January 25, 1989, September 22, 1989, November 6, 1990, May 28, 1992, and October 2, 1992; and
