FIRST: That the Articles of Incorporation shall be amended by deleting Article 1 in its entirety and substituting the following in lieu thereof:

ARTICLE 1

"The name of the Corporation is **CONTOUR MEDICAL OF CENTRAL FLORIDA, INC.**"

SECOND: That pursuant to Section 607.181(4) of the Act, the foregoing amendment was approved by resolution adopted by the unanimous written consent of the holder of record of all the outstanding stock of the Corporation entitled to vote thereon on July 2, 1997.


