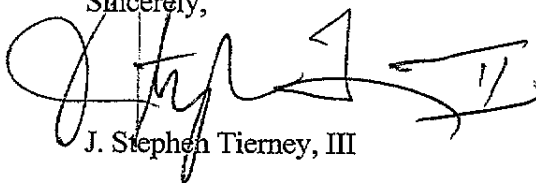

**ARTICLES OF DISSOLUTION**  
**PURSUANT TO**  
**SECTION 607.1403 OF THE FLORIDA STATUTES**

Pursuant to the provisions of Section 607.1403 of the Florida Statutes, the undersigned Corporation adopts the following Articles of Dissolution for the purpose of dissolving the Corporation:

1. The name of the Corporation is DRISCOLL BROTHERS GROVES, INC.
2. The dissolution of the corporation was authorized by written consent of the shareholders on the 5th day of September, 2001. This dissolution was approved by the shareholders by written action pursuant to Florida Statute 607.1402(6) and 607.0704 .
