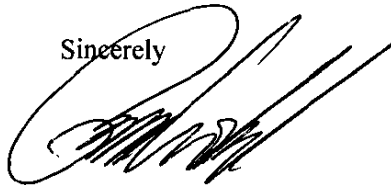
I have three (3) separate corporations that I renew every year.
