AMENDED AND RESTATED ARTICLES OF INCORPORATION

OF

The following Amended and Restated Articles of Incorporation supersede the existing Articles of Incorporation of KATIN,

DOSORETZ RADIATION THERAPY ASSOCIATES, P.A., a Florida

Professional Service Corporation (the "Corporation"):

I. NAME OF CORPORATION

The name of this Corporation shall be KATIN, DOSORETZ
