

Gentlemen,

Please find enclosed a completed request for a Corporate Reinstatement. Also enclosed is my corporate check in the amount of \$300, to be applied as \$150 for calendar year 2001 and \$150 for calendar year 2002 as instructed by a member of your staff.

I was recently advised by an insurance company that they had found my corporation, Kendzior Financial Group, Inc., to be listed on your records as inactive. My research into this through the www.sunbiz.org web site revealed that you have my old mailing address and no reference to an annual report for 2001. You appear to have applied an administrative dissolution. Since my corporation is active and files annual tax returns with the IRS, this clearly needs to be corrected.

This is a request for you to waive the reinstatement fee. I never received the necessary paperwork to file my report in a timely manner. In 2000, my mailing address changed when the private mail service we use moved to another location. We had been assured by the Post Office that all official mail would be forwarded for 12 months but this did not happen. The address of my Principal Office has not been changed but apparently it is not your policy to send mail to that location. Is this correct?

Please amend your records so that all future mail is sent to the mailing address as shown above. The correct mailing address for this corporation is 7257 NW 4th Blvd., PMB144, Gainesville, FL 32607.
