Please find enclosed a completed request for a Corporate Reinstatement. Also enclosed is my corporate check in the amount of \$300, to be applied as \$150 for calendar year 2001 and \$150 for calendar year 2002 as instructed by a member of your staff.

I was recently advised by an insurance company that they had found my corporation, Kendzior Financial Group, Inc., to be listed on your records as inactive. My research into this through the www.sunbiz.org web site revealed that you have my old mailing address and no reference to an annual report for 2001.
