- 2. The amendment to the Articles of Incorporation being effected hereby will be the number 66,000 in Article Fourth of the Articles of Incorporation as of the date hereof, and substitute in its place the number 132,000.
- 3. As amended hereby, Article Fourth of the Articles of Incorporation has the effect of increasing the number of authorized shares of capital stock of the Corporation.
- 4. This amendment to the Articles of Incorporation was approved by the unanimous written consent of the directors and stockholders of the Corporation on the 16<sup>th</sup> day of April 2000.
