ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF

MODDATA, INC.

MODDATA, INC., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), hereby certifies as follows:

1. The name of the Corporation is MODDATA, INC. The date of filing of its original Articles of Incorporation with the Secretary of State was January 11, 1985.

2. Pursuant to and in accordance with Sections 607.1003 and 607.1006, Florida Statutes, these Articles of Amendment to Articles of Incorporation amend certain provisions of the Articles of Incorporation of this Corporation. These Articles of Amendment to Articles of Incorporation were authorized, approved, and ratified by the sole member of the Board of Directors and the sole Shareholder of the Corporation in accordance with Sections 607.0704 and 607.0821, respectively, of the Florida Business Corporation Act.

3. A new Article X is hereby added to the Articles of Incorporation of the Corporation as follows:

"ARTICLE X. INDEMNIFICATION

The Corporation shall indemnify any incorporator, officer or director, or any former incorporator, officer or director, to the full extent permitted by law."

4. The foregoing amendment to the Articles of Incorporation were unanimously adopted by the sole member of the Board of Directors and the sole Shareholder of the Corporation on the 2nd day of OCTOBER, 2012.
