

ARTICLES OF AMENDMENT

The undersigned officer, for the purpose of amending the Amended and Restated Articles of Incorporation of Destin Bank, a Florida banking association, does hereby submit the following Articles of Amendment and does state as follows:


1. The name of the corporation is Destin Bank.
2. The existing Amended and Restated Articles of Incorporation of Destin Bank are amended by adding a new Section 3 to Article II to read as follows:

Section 3. The corporation shall have such trust powers as authorized by Chapters 658 and 660 of Title XXXVIII of the Florida Statutes, as now in effect or as may hereafter be amended.

3. The Amendment does not provide for any exchange, reclassification or cancellation of issued shares.
4. The Amendment was approved by a majority of the Board of Directors of Destin Bank on August 19, 1997.
5. The Amendment was approved by the unanimous Written Consent of the Sole Shareholder of Destin Bank on February 6, 1998.
6. There being only one shareholder of Destin Bank, and all shares held by the sole shareholder being cast in favor of the Amendment, the votes FOR the Amendment by the shareholder were sufficient for approval of the Amendment.

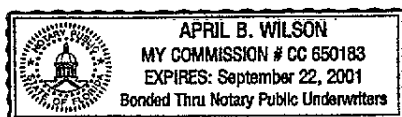
