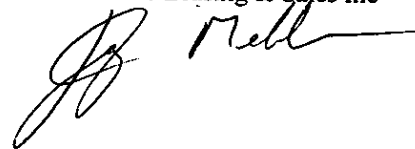
To whomever it may concern,

I am writing this letter as an officer of Creative Leasing & Sales Inc. I have just received my second notice for my 2002 Uniform Business Report. I understand that because I am delinquent there is a \$400.00 penalty. I know it is my responsibility to get the report filed on time.

I would like to ask for your leniency in this matter. This has been a rough year in the car rental business in Florida. I've been in business for seventeen years in Florida. After September 11th the bottom fell out of the car rental business. We have been extremely low on capital. We applied for a disaster relief loan from the S.B.A. to help us pay our bills.
