

## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SPACE COAST PATHOLOGISTS, P.A.

- 1. The name of the corporation is SPACE COAST PATHOLOGISTS, P.A.
- 2. The following amendment of the articles of incorporation was adopted by the Directors and shareholders of the corporation, in the manner prescribed by the Florida Business Corporation Act:
