**ARTICLES OF DISSOLUTION

Pursuant to the provisions of Section 607.1403 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Dissolution for the purpose of dissolving ALEXIS NIHON PROPERTIES CORPORATION, a corporation organized under the laws of the State of Florida ("Corporation"):

1. The name of the Corporation is **ALEXIS NIHON PROPERTIES CORPORATION.**

2. The Articles of Incorporation of the Corporation were filed on March 7, 1985, under document number H45857.

3. The dissolution of the Corporation was authorized by the Sole Shareholder and Directors by unanimous written consent dated as of June 28, 2001.


