Enclosed is a copy of a letter sent along with A & M Keller's 2000 UBR which was sent at the end of July along with a check for \$150 and a letter requesting abatement of \$400 penalty for late filing due to not receiving original form.

The owners of A & M Keller, Inc., Al & Mary Keller, sold their home at 307 E. Lake Brantley (which was also their business address) late last year and currently have no permanent address (they live in a RV and travel between their NC property where they are building a home and staying with their sons in Winter Park, FL) and have had two changes of P. O. Boxes since the sale which has presented a problem with receiving mail.

The Kellers never received the original UBR form, but did finally receive the 2nd notice which they filed along with the check, and letter requesting abatement of penalty for above reasons. Note that A & M Keller, Inc. was incorporated in 1/1986 and has never before missed filing the UBR and under the circumstances, it appears reasonable for waiver of the late filing penalty.
