Dear Annual Report Section,

Per our telephone conversation with your department today, we are resubmitting A. M. Keller's 2001 Annual Report again along with a \$550 check and this explanation letter.

A. M. Keller changed its address in 2000 when the owners sold the home to a P. O. Box in Longwood, FL.

A. M. Keller did not receive its initial UBR due to the City listed as Altamonte Springs, FL 32714 instead of Longwood, FL 32791. A. M. Keller did receive the late notice (which was forwarded from Altamonte Springs after significant delay) and completed that form along with a check for \$150 in August and a letter asking for waiver of penalty based upon non receipt of the original notice. According to the person we spoke with today, the application was rejected and sent back in September with a request to pay a higher amount within 30 days - note that this was sent to Altamonte Springs address and has not been received to date. According to your website, A. M. Keller was Adm. dissolved a few days later on September 21.

The notice of dissolution was sent to the Altamonte Springs address, and then forwarded to the Maitland Post Office and then finally to the Longwood Post Office where we received it this month (cover page with post office corrections enclosed). When we called today for an explanation, we were told to send in the reinstatement form with corrections and a check for \$550 to replace the \$150 check sent earlier and that all other fees would be waived based upon the city being incorrect.

While we would have preferred the previous application accepted along with the check, as we do not have these back and in order to resolve this issue, we are submitting the higher amount with the hope that the \$400 extra penalties would be refunded based upon the circumstances.
