

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF FARR, FARR, EMERICH, HACKETT, CARR AND HOLMES, P.A. NOW KNOWN AS FARR LAW FIRM P.A.

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendment to its Articles of Incorporation of the above-named professional service corporation, filed with the Department of State on March 28, 1985, Charter #H49509, as follows:

1. Article I on page 1 of the Articles of Incorporation of the above-named Florida professional service corporation is hereby revoked in its entirety and the following is substituted in its place:

"ARTICLE I. - NAME

The name of this corporation is FARR LAW FIRM P.A."

- 2. The foregoing Amendment was adopted by the unanimous affirmative vote of the shareholders on December 7, 2024 to be effective on January 1, 2024. The number of votes cast for the Amendment by the shareholders was sufficient for approval.

In every other respect, I hereby confirm and republish the said Articles of Incorporation of FARR, FARR, EMERICH, HACKETT, CARR AND HOLMES, P.A. as filed with the Florida Department of State on March 28, 1985 as amended September 11, 1990, July 2, 1992, December 27, 1993, January 6, 2005, January 15, 2008 and December 11, 2014.
