ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF G. BROOKS BUCK, D.V.M., P.A.

Pursuant to Sections 607.1006(1) and 621.13(4) of the Florida Statutes, the Articles of Incorporation of G. BROOKS BUCK, D.V.M., P.A., a Florida professional corporation (the "Corporation"), are hereby amended as follows for purposes of converting the Corporation from a professional corporation to a general business corporation:
