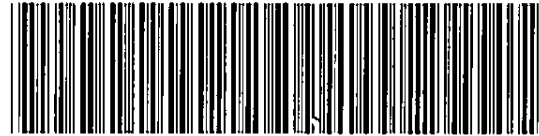

The undersigned subscribers to these articles of incorporation, natural persons, competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is ELIZABETH J. INC.

ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by the corporation is:

To conduct business in, have one or more offices in, and buy, hold mortgages, sell, convey, lease or otherwise dispose of real personal property, including franchises, patents, copyrights, trademarks, and licenses, in the State of Florida and all other states and countries; to include the construction, operation and maintenance of vessels and engage in the commercial fish business in all aspects.

To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidence of indebtedness and execute such mortgages, transfers or corporate property, or other instruments to secure the payment of corporate indebtedness as required.

To purchase the corporate assets of any other corporation and engage in the same or other character of business.

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock, of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida, or any other State or government, and while owner of such stock to exercise all of the rights, powers and privileges of ownership, including the right to vote such stock.

This corporation may engage in any activity or

business permitted under the laws of the State of Florida
and the laws of the United States.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having a nominal par value of \$1.00 per share. The consideration to be paid for each share of stock shall be affixed by the stockholders.

ARTICLE IV. INITIAL CAPITAL

The amount of capital with which the corporation will begin business is \$1,000.00.

These articles of incorporation may be amended in the manner provided by law. Every amendment shall be approved by the stockholders, approved at a stockholders' meeting by a majority of the stock entitled to vote thereon, unless all of the stockholders sign a written statement manifesting their intention that a certain amendment of these articles of incorporation be made.

ARTICLE XI. CORPORATE EXISTENCE

ARTICLE XIII

Due to the particular nature of the fishing business each stockholder agrees that as long as the majority of the income of the corporation is from fishing that every stockholder who might desire to sell his or her stock shall first offer to sell the stock to the corporation and upon refusal or failure of the corporation to purchase the stock to then offer it to the other stockholders in order of seniority of ownership of stock.

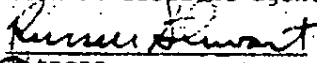
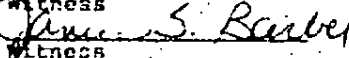

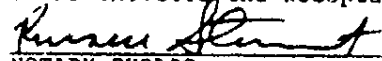
