4. That the signatories hereto are all of the shareholders of all of the outstanding capital stock of the corporation as of the date hereof.

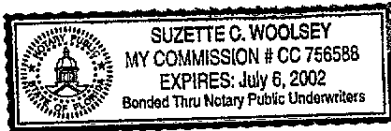

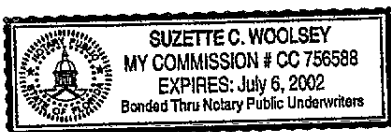
