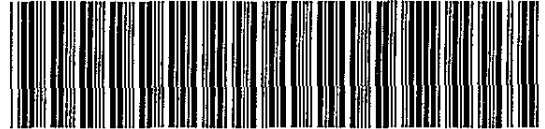

Pursuant to FSA § 607.1403, this corporation submits the following Articles of Dissolution:

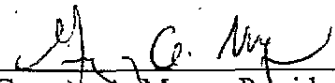
1. The name of the corporation is ATLANTIC ASSETS, INC.
