**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
CRS CENTRAL ROOFING SUPPLY, INC.**

Pursuant to the provisions of section 607.1006 of the Florida Statutes, CRS CENTRAL ROOFING SUPPLY, INC. hereby adopts the following Articles of Amendment to its Articles of Incorporation:
