
We are the parent corporation of the above-referenced entity and are responding to your 2000 Uniform Business Reports due between January and May (copy enclosed). The form indicates that a penalty of \$400.00 has been assessed for late filing.

For your information Davel Communications, Inc. has had two major acquisitions in the past two years. The combination of these companies has been a difficult one. Significant employee turnover has hampered the transition of the accounting functions into Davel. In addition, Davel relocated its corporate headquarters from Jacksonville, Illinois to Tampa, Florida in November of 1998. New employees of the tax department have taken on the responsibility of the annual reports. These employees have the task of determining the necessary filing requirements for the various jurisdictions, and have begun to research and attempt to meet the various jurisdictions reporting requirements.
