

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF JOHNSON'S CAMPER SALES, INC.



The undersigned, GLENN E. JOHNSON, President, and DORIS C. JOHNSON, Secretary, of JOHNSON'S CAMPER SALES, INC. certify that:

- 1. They are the President and Secretary of JOHNSON'S CAMPER SALES, INC., a Florida corporation, which Articles of Incorporation were filed with the Department of State. State of Florida, on April 25, 1985 and last amended on July 22, 1996.
