5. The surviving entity herein has agreed to pay any members of any limited liability company with appraisal rights the amount to which such members are entitled under the provisions of Sections 605.1006 and 605.1061-605.1072, Florida Statutes.
6. The effective date of the merger will be the date of filing these Articles of Merger.
