Pursuant to the provisions of Sections 607.181 and 607.187, Florida Statutes, the undersigned corporation, **SUSAN C. SCHULER AND ASSOCIATES, INC.**, a Florida corporation (the "**Corporation**"), adopts the following Articles of Amendment to change its corporate name and amend its Articles of Incorporation:

1. **Present Corporate Name.** The present name of the Corporation is :

2. **Amendment Adopted.** The amendment adopted provides for the change of the Corporation's corporate name from **SUSAN C. SCHULER AND ASSOCIATES, INC.** to **INDEPENDENT MARKET RESEARCH, INC.**
