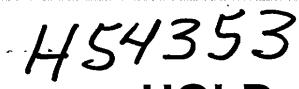

AMENDED AND RESTATED ARTICLES OF INCORPORATION

OF

RICHARD A. SILLS, P.A.

Richard A. Sills, P.A., a corporation organized and existing under the General Corporation Law and Professional Business Corporation Law of the State of Florida (the "Corporation"), does hereby certify:

- I. The Corporation, pursuant to the provisions of Section 607.1007 of the Florida Business Corporation Act (the "Act"), hereby adopts these Amended and Restated Articles of Incorporation (the "Restated Articles"), which accurately restate and integrate the original Articles of Incorporation of the Corporation filed on April 26, 1985 and all amendments thereto.
- II. The Restated Articles contain amendments requiring shareholder approval, pursuant to Section 607.1005 of the Act. The Restated Articles, and all amendments contained herein, were duly and unanimously approved and adopted by the sole shareholder and the directors of the Corporation on May 1, 1998, pursuant to Section 607.1005 of the Act.
- III. The original Articles of Incorporation and all amendments and supplements thereto are hereby superseded by the Restated Articles, which are as follows:
- 1. Name. The name of the corporation is Richard A. Sills, Inc. (the "Corporation").
 - 2. **Duration**. The corporation shall have perpetual existence.
- 3. <u>Purpose.</u> The nature of the business and the purpose for which the Corporation is formed are to engage in any lawful act or activity for which a corporation may be organized under the Act.
- 4. <u>Capital Stock.</u> The corporation is authorized to issue 7,500 shares of common stock with a par value of \$1.00 per share.
- 5. Registered Office and Registered Agent. The street address of the registered office of the corporation is: 2248 First Street, Fort Myers, Florida 33901, and the name of the registered agent of the corporation at that address is: RICHARD W. WINESETT.
- 6. <u>Initial Board of Directors</u>. The corporation shall have one (1) director initially. The number of directors may be either increased or diminished from time to time by the

Bylaws but shall never be less than one (1). The name and address of the initial director of the corporation is: Richard A. Sills, 6055 MacBeth Lane, S.W., Fort Myers, Florida 33908.

- 7. **Incorporator.** The name and address of the person signing these Articles is: Richard A. Sills, 6055 MacBeth Lane, S.W., Fort Myers, Florida 33908.
- 8. Amendment. The corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment to them, and any right conferred upon the Shareholders is subject to this reservation.
