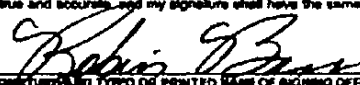

The sole owner, director and president of TRAW Engineering Corporation (the "Corporation"), Herbert A. Bass, died on October 2, 1999. Debbie L. DeVries was appointed personal representative of Mr. Bass' estate, and kept it active until her death on July 27, 2002. Because of her death and the events precipitating it, she did not file an annual report in 2002, and the Corporation was administratively dissolved on October 4, 2002.

Paula R. Bass took over as personal representative of Mr. Bass' estate following the death of Ms. DeVries. At that time, Ms. Bass believed the assets of the Corporation to have been disposed of by the previous personal representative and was unaware of any continuing need to file annual reports on behalf of the Corporation. If any notices were sent, they went to Ms. DeVries former address in Orange Park, and they were never received by the new Personal Representative.

Upon Paula Bass' death earlier this year, Robin Bass took over as personal representative of the Estate of Herbert A. Bass, and discovered that assets were still titled in the name of the corporation. Therefore, Robin Bass is filing the enclosed Corporate Reinstatement. She is further requesting relief from the \$600.00 penalty fee on the grounds that both she and the previous personal representative were unaware that the corporation still held assets, nor were any

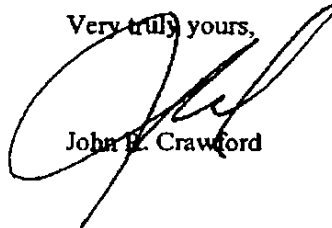

notices received by either of them notifying them of the need to file annual reports. We further submit that, due to the fact that there have been three personal representatives of this estate, two of whom died of accidents at a relatively young age, there is reasonable cause for failure to file the reports. Accordingly, the penalty should be waived.

Therefore, we are enclosing the Corporate Reinstatement form together with our check in the amount of \$750.00, representing the reinstatement fee. Please issue a certificate of status to be picked up by a representative of CorpDirect.
