FELDSTROM, INC., a Florida corporation organized and existing under the laws of the State of Florida (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Chapter 607, Florida Statutes, does hereby certify as follows:

- 1. The Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Florida on May 10, 1985, under the name "FELDSTROM, INC."
- The amendment to the existing Articles of Incorporation being effected hereby is a change in the name of the Corporation from "FELDSTROM, INC." to "W.G. MILLS, INC., OF VERO"
- 3. These Articles of Amendment were approved by joint written action of the Board of Directors and the stockholders of the Corporation as of the $\frac{92}{100}$ day of $\frac{100}{100}$, 1997.
- 4. After payment of all required taxes and fees, these Articles of Amendment are to be effective immediately upon filing with the Secretary of State of the State of Florida, at which time the existing Article I of the Articles of Incorporation of the Corporation shall be deleted in its entirety and the following Article I shall be substituted in its place and stead:

ARTICLE I

Name

The name of this corporation shall be: W.G. MILLS, INC., OF VERO"
