

RESTATED ARTICLES OF INCORPORATION OF JIMMY'S TREE SERVICE, INC.

These Restated Articles of Incorporation of Jimmy's Tree Service. Inc., a Florida corporation, have need adopted as required under the provisions of the Florida Business Corporation Act and upon the effective date supersede and replace the originally filed articles of incorporation (together with any amendments thereto).

ARTICLE I EFFECTIVE DATE

These Restated Articles of Incorporation shall be effective on January 31, 2024. The date of adoption of the restated articles by the shareholders is January 31, 2024.

ARTICLE II NAME

The name of this corporation is JIMMY'S TREE SERVICE, INC. (the "Corporation").
