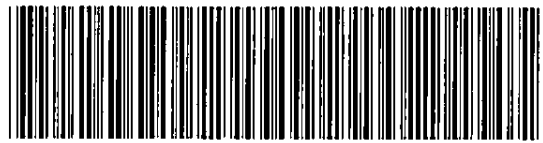

The Articles of Incorporation of the Corporation were filed on May 23, 1985, and assigned Document Number H58453.


ARTICLE III.

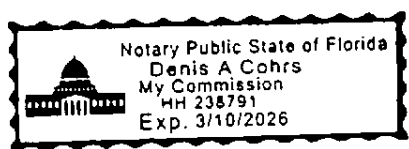


