The name of the corporation is : **VALLEY LAND CO., INC.**

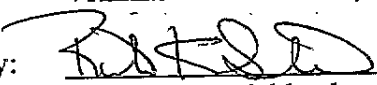
The shareholders of the company approved the dissolution of the company on January 28, 2000.
