Pursuant to the provisions of Section 607.10025 of the Florida Business Corporation Act (the "FBCA"), the undersigned, Safeskin Corporation, a Florida corporation (the "Corporation"), by its President, Chief Executive Officer and Director, does hereby make and execute this Certificate of Amendment:

- (a) The name of the Corporation is Safeskin Corporation.
- (b) The board of directors adopted a resolution on February 17, 1998 approving a division of the Corporation's Common Stock, par value \$.01 per share.
- (c) The amendment to the articles of incorporation does not adversely affect the rights or preferences of the holders of outstanding shares of any class or series and does not result in the percentage of authorized shares that remain unissued after the division exceeding the percentage of authorized shares that were unissued before the division.
- (d) 26,858,822 shares of the Corporation's Common Stock, par value \$.01 per share, are subject to division and shall be divided into 53,717,644 shares of the Corporation's Common Stock.
- (e) In connection with the division, Section (1) of Article V of the Corporation's Articles of Incorporation is amended in its entirety to read as follows:
 - (1) <u>Authorized Capital Stock</u>. The aggregate number of shares which the Corporation shall have authority to issue is 90,000,000, consisting of 80,000,000 shares of Common Stock, \$0.01 par value per share, and 10,000,000 shares of Preferred Stock, \$0.01 par value per share.
