## ARTICLES OF RESTATEMENT OF ARTICLES OF INCORPORATION OF VINTAGE MOTORSPORT, INC.

#### **Document Number H60465**

Pursuant to the provisions of section 607.1007, Florida Statutes, this Florida Profit Corporation restates its Articles of Incorporation as follows:

#### **ARTICLE 1 – NAME**

The name of the corporation is VINTAGE MOTORSPORT, INC.

#### <u>ARTICLE II – PRINCIPAL OFFICE</u>

The principal place of business and mailing address:

5151 South Lakeland Drive Suite 15 Lakeland, FL 33813

#### **ARTICLE III - SHARES**

The number of shares the corporation is authorized to issue is 100,000 shares of common stock.

#### **ARTICLE IV - PREEMPTIVE RIGHTS**

The Corporation elects to have preemptive rights as provided for and set forth at Section 607.0630 of the Florida Business Corporation Act (1989). By way of amplification and not of limitation, each stockholder will have such rights in proportion to his other stock rights. Such preemptive rights must be exercised by any stockholder so electing within 30 days after being offered to the shareholders, or, otherwise, the preemptive rights as to that offering shall be deemed to have been waived.

#### **ARTICLE V – RIGHTS ON REDEMPTION**

The Corporation may acquire its outstanding shares from its stockholders but only after offering to purchase from each stockholder that number of shares determined by each such stockholder's then percentage of stock ownership. Such right to participate in the Corporation's acquisition of its own shares shall be deemed waived by each stockholder who does not exercise his or her right to so participate within 30 days of the offer of redemption. The Corporation may redeem its outstanding preferred stock without being obligated to offer to redeem its outstanding common stock.
