ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF

The undersigned corporation, in accordance with the Florida Business Corporation Act, and its Bylaws, hereby adopts the following Articles of Amendment:

1. The name of the corporation is KIDNEY LIFE, INC.
2. Article IX of this corporation's Articles of Incorporation as amended to date, is hereby amended in its entirety so as to read, after amendment, as follows:

"ARTICLE IX

Board of Directors
