
This letter is in response to our conversation today. You had indicated that you wanted all correspondence sent to your attention for your review.

We had originally spoke with Doug Spitler on 06/27/01 and explained to him that the original UBR form for year 2000 was applied to Sebastian Hearing Aid Centers in error. After realizing this error Mr. Spitler was to reapply the UBR for 2000 and apply it to Gulf Atlantic Hearing Aid Centers. This still leaving Gulf Atlantic Hearing Aid Centers to file the UBR for 2001.
