ARTICLES OF AMENDMENT

OF

KARP & GEWIRTZ OF FLORIDA, INC.



To the Department of State State of Florida

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the corporation hereinafter named (the "corporation") does hereby adopt the following Articles of Amendment.

- 1. The name of the corporation is Karp & Gewirtz of Florida, Inc.
- 2. Article 1 of the Articles of Incorporation of the corporation is hereby amended so as henceforth to read as follows:
