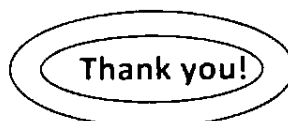

Pursuant to Section 607.1403, Florida Statutes, the undersigned Florida profit corporation adopts the following Articles of Dissolution for the purpose of dissolving the corporation:

1. The name of the corporation as currently filed with the Florida Department of State is Diabetes Medical Supply, Inc. (the "Corporation").

2. The Articles of Incorporation were filed on July 22, 1985, and assigned document number H67439.

3. The Corporation was administratively dissolved on August 25, 1995.

4. The Corporation ceased doing business in the State of Florida as of March 15, 1995, and all activities to wind up and liquidate the Corporation have been completed. The shareholders and directors of the Corporation now desire to file these Articles of Dissolution to evidence the same and to confirm the voluntary dissolution of the Corporation.

5. The effective date of the dissolution shall be the date of filing of these Articles of Dissolution; however, the effective date of dissolution for accounting purposes shall be March 15, 1995.

6. The date the dissolution pursuant to these Articles of Dissolution was authorized is March 13, 2019.

7. The dissolution was approved by the shareholders, and the number of votes cast was sufficient for approval.
