ARTICLE I: The name of the corporation is ABLE LAND HOLDING CORPORATION.

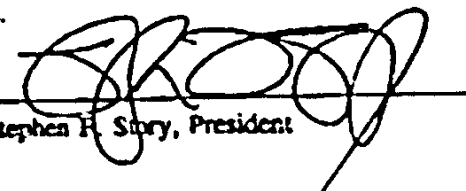
ARTICLE II: All of the liabilities and obligations of the corporation have been paid or discharged, or adequate provision for them has been made.

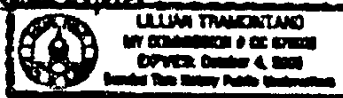
