Gentlemen/Ladies:

Technica, Inc. filed its Uniform Business Report on, UBR, on line in January 2001, using a Master Credit Card (*card number and expiration date on request*) as payment of the \$150.00 filing fee immediately upon receipt of the 2001 UBR document number #H69993. The on line filing followed the instructions by going to the Division's "SUNBIZ" page at www.sunbiz.org and clicking on "Electronic Filing" and selecting "Uniform Business Report". There was no indication of an error in the filing by the instructions of the on-line UBR.

A second notice UBR, purportedly sent in June 2001 by the Division, was and has not been received as of this date by **Technica, Inc.** - so there was nor has there been an indication that something was amiss.

The prompted filing instructions were followed precisely. It should be noted, however, that upon inspection of credit card files after the receipt of the Revocation Certificate, does not reveal a record of charge of the UBR filing fee on-line.

It would appear, therefore, that **Technica, Inc.**'s receipt this date of document #H69993 - a "Certificate of Administrative Dissolution or Revocation" is unintentionally in error.

Following the instructions of the Division's phone representative as a result of a call to (850) 245-6059 at approximately 10:15 AM, to correct this unfortunate error, a check for \$150.00, the original filing fee, is enclosed. It is therefore requested that **Technica, Inc. be reinstated as a Florida Chapter "S" Corporation at the earliest practical date.**
