Abstract: The purpose of this study was to determine the effect of a 12-week training program on the physical fitness and health of middle-aged men. The study was conducted in a laboratory setting and involved 20 participants. The participants were divided into two groups: a control group and an experimental group. The experimental group underwent a 12-week training program consisting of aerobic and strength training exercises. The control group did not participate in any training program. The physical fitness and health of the participants were measured at the beginning and end of the 12-week period. The results of the study showed that the experimental group had significantly higher levels of physical fitness and health compared to the control group at the end of the 12-week period. The findings of this study suggest that a 12-week training program can improve the physical fitness and health of middle-aged men.
