2. Article I of the Articles of Incorporation is hereby amended to read in its entirety as follows:



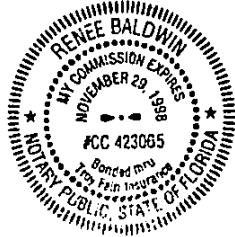
