ARTICLES OF AMENDMENT TO AMENDED AND RESTATED ARTICLES OF INCORPORATION OF SOUTHEASTERN ALUMINUM PRODUCTS, INC.

The undersigned officer of Southeastern Aluminum Products, Inc. (the "<u>Corporation</u>"), Document No. H73707, hereby adopts the following Articles of Amendment to Amended and Restated Articles of Incorporation of the Corporation pursuant to Section 607.1006 of the Florida Business Corporation Act:

1. The Amended and Restated Articles of Incorporation hereby are amended by deleting Article I in its entirety, and by substituting the following in its place:

ARTICLE I - NAME

The name of the corporation is SEA Products, Inc.

- 2. Except as amended in paragraph 1 of these Articles of Amendment, the Corporation's Amended and Restated Articles of Incorporation remain unchanged.
- 3. In accordance with Section 607.1003 of the Florida Business Corporation Act, the amendments made herein were adopted by unanimous written consent of the Corporation's Board of Directors and by unanimous written consent of the Corporation's shareholders on August 25, 2017, and the number of votes cast for the amendment by the Corporation's Board of Directors and the Corporation's shareholders was sufficient for approval.
