Pursuant to the provisions of Florida Statute Section 607.1006, this corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Pebbles Restaurants, Inc.
2. Article 1 of the Articles of Incorporation of Pebbles Restaurants, Inc. is hereby amended in its entirety to read as follows:

ARTICLE 1

The name of the corporation is Plantation Grill, Inc.
